The action is done in cooperation with the [Baltic Sea e-Nav project](#), where Traficom (Jarmo) coordinates the harmonisation for all S-100 standards. FMI (Anni) coordinates and collaborates with SMHI (Patrik) on the S-104/S-111 implementation.

A first version of a [Regional product harmonisation document for S-104 and S-111](#) has been drafted.

**Please read it and provide your comments and feedback at the meeting or by 19<sup>th</sup> June 2025.**

**Our ambition and the first goal of the group is to have a first version of the document**, to be presented and acknowledged at the BSHC30 Conference, 22-24 September 2025 in Riga. Last due date for the report and submissions to the Conference is six weeks prior to the meeting, i.e. 2025-08-15.

We will also try to coordinate as much as possible with the other standards, such as S-102. Please find attached the first version of the **Regional product harmonisation guidelines for S-102**, produced in cooperation between the [Baltic Sea e-Nav project](#) and [BSICCWG](#). A new version will be available this summer.

You are very welcome to give input and feedback about our way forward.
