Statement from the Republic of China

There are several reasons why the timeline of task item B.3 should be changed:

- 1.According to S-130 PT work plan 2022-2025, this task should start from 2024 and end in 2025, however, the task has not been started in 2024 because the lack of operational edition of S-130 and S-158:130 and the enough experiences in producing and validating the S-130 sample dataset. Therefore, it is necessary to change the start date from 2024 to 2025 and change the end date from 2025 to 2027 so that the Project Team has enough time to have some in-depth discussion and complete the task.
- 2. The operational edition of S-130 has not been tested and still needs be improved based on the experiences in producing more sample dataset. In addition, S-158:130 is also not mature enough to support the validation of the S-130 dataset, so a new edition 2.0.0 will be absolutely necessary before the production of the IHO S-130 authoritative dataset.
- 3. S-130 belongs to phase 2 or phase 3, so there is no reason or necessity to finish the production and release of the IHO S-130 authoritative dataset before a large number of Phase 1 products has been produced and released by most of Member states. Furthermore, the production of S-130 dataset also relies on the experiences collected in producing Phase 1 products on a large scale and over a longer period of time, and it is not possible to get enough experiences before 2026.
- 4. There is still a lot of work need to be done before officially starting the production of IHO S-130 authoritative dataset. For example, the project team needs to discuss and reach consensus on the solution of the production of IHO S-130 authoritative dataset which includes but not limited to how to make sure the member states could be able to participate in the production, how to collect source data from member states, what is the review and approval procedures of source data, which production software and validation software will be used, etc. Considering the complexity and the difficulty of this task and the limit of time before the current end date, it is difficult for the project team to finish the task item by 2025.
