We have the privileged to invite you to the BSHC MSDI working group Workshop 2.

The overall aim of the workshop is to create a common MSDI framework in order to establish a BSHC MSDI work plan for the Baltic Sea which will focus on how the BSHC can benefit from a regional approach to MSDI.

The two-day Baltic MSDI Workshop 2 will be held in Copenhagen on September **24-25**, **2013**. The workshop will start at 10:00 on, Tuesday September 24 and will end on Wednesday, September 25 at 16:00, and will take place at the Danish Geodata Agency's' premises at **Rentemestervej 8**, **Copenhagen**, **Denmark**.

Day 1of the Workshop is intended to be a general presentation from IHO MSDIWG, national presentation from members on status on SDI, MSDI and INSPIRE and a presentation of the proposal for a directive of the European Parliament and of the Council establishing a framework for maritime spatial planning and integrated coastal management (See appendix A for the detailed schedule).

Day 2 of the workshop is intended to focus on the questionnaire about national use of data, the proposal for a directive of the European Parliament and of the Council establishing a framework for maritime spatial planning and integrated coastal management.
