BSHC MWG14 meeting draft minutes

1. The minutes from MWG13 meeting (Norrköping, February 2016) were accepted. The status of the tasks from MWG 13 meeting were reviewed. [chair]

Accepted, tasklist discussed thru, some tasks ongoing (see tasklist at the end)

- 2. BSHC21 (Klaipeda) decisions concerning BSHC Re-Survey Monitoring Working Group (MWG)
 - The MWG report was presented by chair Mr. Seppo H Mäkinen The Conference took note on the MWG report.
 - encouraged member states to study and define Cat I & II areas in their waters based on the existing AIS-information on commercial shipping
 - encouraged member states to perform re-surveys in areas of commercial shipping
 - The BSHC20 did not append the presented MWG work program for 2014-2016. The MWG work program for 2017-2020 is as item 6.

Chair presented the MWG presentation at BSHC21. Discussion on HELCOM re-survey plan being a dynamic plan, based on the AIS records.

- 3. The re-survey status and progress made since MWG13, as well as survey plans (e.g. within FAMOS) [chair]
 - Denmark, Finland, Germany, Poland and Sweden presented re-survey progress of HELCOM cat I & II area surveys as well as preliminary survey plans for upcoming years;

Statistics were reviewed from BSHC21 MWG report. Participating MS presented their completed areas and plans of surveys to start 2017. It was noted that re-survey plan and CAT I & II areas are not static, but a living plan to be updated based on information and changes in SOLAS shipping based on AIS information.

- 4. to discuss contributions for the S-44 ed 5 work [currently through representation at scoping team, CL-83/2015, HSSC 7/03]
 - S-44 ed 5 update, representation from BSHC in the IHO working group. MWG individual members shall inform other MWG members of the progress [DE & SE];



Thomas Dehling gave a report on survey scoping project team: is there a need of WG for revising S-44. Scoping team will report HSSC meeting in Monaco (next week, week 46 2016), proposal: there is a need for updating S-44 (but influence to other S- XXX publications).

FI and SE will discuss the FSIS-44 update need in bilateral meeting in the spring 2017.
