Dear BSHC and Re-Survey Monitoring Working Group Colleagues,

This letter contains information based on the decisions of the BSHC 20th Conference on 10-12 Sept 2015, St. Petersburg, Russia. Also it contains information of the forthcoming MWG13 meeting on 10 <u>February 2016</u> at Swedish Maritime Administration, in Norrköping, Sweden.

1. BSHC 20 decisions concerning BSHC Re-Survey Monitoring Working Group (MWG)

The MWG report was presented by MWG vice-chair Mr. Thomas Dehling The Conference took note on the MWG report.

The BSHC20 did not append the MWG work program for 2014-2016, so we continue as planned.

2. "Hands on" workshop on Re-Survey DataBase interface on Tue 9 Feb, 2016

As agreed in MWG 12 meeting in Riga, a "hands on" workshop for Re-Survey DataBase will be arranged by our colleagues at Swedish Maritime Administration on Tuesday 9 Feb 2016 in the afternoon, commencing at 13:00.

All BSHC Re-Survey DataBase national operators should participate and give their effort to get the user interface suitable for all.

3. Date and venue of the MWG13 meeting at Swedish Maritime Administration in Norrköping, Sweden on 10 February 2016

- to review the work program for 2014 2016 and to draft work program for 2017-2020[chair];
- to plan for a MWG14 meeting (time and proposals for venue are welcomed) [chair];


